DEFINITIONS

- a) "Personal Injury" has in ordinary English meaning and includes any injury for which a person might be awarded under General damages and/or Special Damages at Common Law.
- b) "The Releasors" means the Family, Dependants, Heirs, Executors and/or assigns and any person claiming through them.
- c) "The Releasees" means any Corporation, Association, or any other Body and/or Person(s) jointly and severally and whether Servants or Agents of any of the aforementioned or otherwise where any such, are Corporation, bodies or individuals that is associated with the promotion or conduct of the Tournament and includes Competitor(s), Referee(s), Volunteers(s), and observers or members of the audience.
- d) "Any Action" means any claim, right of cause and/or, course of action for damages at Common Law or pursuant to any statute in all countries.
- e) "The Rules" means the rules for the time being of the Unified International Taekwon-Do Federation (UITF) and Worldwide Taekwon-Do and it's Affiliates.

DISCLAIMER AND WAIVER

- 1. I acknowledge that I have read the definitions set out above.
- 2. I hereby acknowledge that my entry and or participation in the Tournament carries with it significant risk of personal injury.
- 3. Therefore, I for myself and the Releasors hereby relinquish, release and/or waive all or any claims, right of cause or any action that I may otherwise have, arising from out of any injury or loss of life, damage or loss of any description whatsoever which I may suffer or sustain in the course of or consequent upon, my acceptance in these Championships.

This waiver, release discharge shall be, and operates jointly and separately, in favour of all persons, corporations, association or bodies involved or otherwise engaged and the servants, agents, representatives and officers of them, (the Releasees,) for any personal injury sustained by me arising out of and/or in the course of the Tournament whether as a result of any disregard and/or technical breach of any Rules of the Tournament or otherwise.
